SECTION III. Multi-Stakeholders Inspectorate Team (MSIT) Functions. The MSIT shall exercise the following functions:

- 1. Conduct sustainability evaluation using the prescribed Sustainability Evaluation Tool template depending on the sub-project type every six months of the sub-project completion;
- 2. Undertake actual inspection on the completed sub-projects by assessing its physical and technical condition of the structures;
- 3. Determine if standards were met in implementing NCDDP-sub-projects and recommend improvements or actions as deemed necessary;
- 4. Conducts action planning and tactic session;
- 5. Submitted fully furnished reports and assessment of inspected sub-projects;
- 6. Document laddered activities of the team;
- 7. Conduct the Post-Sustainability as the need arises;
- 8. Monitor the implementation plan using the operation and maintenance tool.

SECTION IV. EFFECTIVITY. This Executive Order shall take effect immediately and shall be in full force and effect unless otherwise repealed and/or superseded by succeeding orders;
