**MUNICIPAL ORDINANCE NO. 06**  
*Series 2023*

**“AN ORDINANCE RENAMING MABITBITNONG PRIMARY SCHOOL TO MABITBITNONG ELEMENTARY SCHOOL, THIS MUNICIPALITY.”**

**WHEREAS**, under Section 13, par. (c), of Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”, the local members of the Sanggunian are vested with the power to change or rename a public school upon the recommendation of the Local School Board concerned within its territorial jurisdiction;

**WHEREAS**, the Department of Education- Sto. Nino District through Dr. Genalyn Oarde, Cluster Principal of Mabitbitnong Primary School had requested the enactment of an ordinance renaming the said school into elementary school because the said legislative measure is one of the requirements for the conversion of the said school into elementary school;

**WHEREAS**, after a careful evaluation, this August Body finds the request of Dr. Oarde is to be of merit and it will surely redound to the benefit of our constituents especially the pupils of the said barangay;

**WHEREAS**, with increasing number of pupils from kindergarten to grade six, there is a need to rename the school.

**NOW THEREFORE**, on motion of Hon. Edgar T. Tulali, Chairman of the Committee on Education, Culture and the Arts and Cultural Heritage, duly seconded by all members present;

**BE IT ENACTED** by the Sangguniang Bayan of Sto. Nino, Cagayan, in a session assembled, that:

**SECTION 1. TITLE.** This Ordinance shall be known as “The Ordinance Renaming Mabitbitnong Primary School to Mabitbitnong Elementary School.”


**SECTION 2.** The Mabitbitnong Primary School located at Brgy. Mabitbitnong, Sto. Nino, Cagayan is hereby renamed to Mabitbitnong Elementary School.

**SECTION 3. REPEALING CLAUSE.** All ordinances whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended and modified accordingly.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect upon approval.
